- Link Academy Trust, (the "Company") a charitable company incorporated in England and Wales with registered number 10049068, together, the "Parties".

INTRODUCTION

- A. Stoke Gabriel Primary School is an academy within the meaning of the Academies Act 2010 and is currently operated by the Company (a multiacademy trust) the "Academy".
- B. The Parties entered into a supplemental funding agreement dated on or about 29 March 2016 (the "Supplemental Funding Agreement") relating to the establishment, maintenance and funding of an Academy in accordance with the Supplemental Funding Agreement.
- C. The Parties now wish to vary and amend certain terms and conditions of the Supplemental Funding Agreement in accordance with the terms of this Deed.
- D. This Deed is supplemental to the Supplemental Funding Agreement.

1. INTERPRETATION

1.1 Words, expressions and interpretations used in this Deed shall, unless the context expressly requires otherwise, have the meaning given to them in, and shall be interpreted in accordance with, the Supplemental Funding Agreement.

2. VARIATION OF THE SUPPLEMENTAL FUNDING AGREEMENT

- 2.1 The Parties agree that with effect from the date of this Deed the Supplemental Funding Agreement shall be amended and re-stated in the form of the amended Stoke Gabriel Primary School Supplemental Funding Agreement set out in the Schedule.
- 2.2 Except as varied by this Deed, the Supplemental Funding Agreement shall remain in full force and effect.

Governing law and jurisdiction

- 3.1 This Deed, and any disputes or claims arising out of or in connection with it, its subject matter or formation (including non-contractual disputes or claims), shall be governed by and construed in accordance with English law.
- 3.2 The parties irrevocably agree that the English courts have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed

or its subject matter or formation (including non-contractual disputes or claims).
